- b. PB provided the committee with an overview of how the previous steering group had come into being, the work it had done and the recent decision making by the Town Council. He drew attention to statutory requirements as to membership and process that the successor body would need to follow. He also noted that the previous group had been complimented for their work by both SHDC and Historic England.
- c. JW reported on the decision processes of the Town Council and how it was able to reverse an earlier decision to continue to work with the previous steering group.
- d. The committee agreed that it should comment to the

The Committee agreed to discuss further at the end of the meeting.</p> <p>e. Dartington – Nothing to report.</p> <p>7. Matters raised by members</p> <p>a. Proposed development at Whiterock, Paignton</p> <p>It was noted that the proposal falls outside the Totsoc area however Totsoc has an interest in the AONB that would be affected by the proposal. PB considered that approval was unlikely as it was inconsistent with the relevant local plan and that there was perceived to be something of an oversupply of residential development in the Torbay area.</p> <p>b. Proposed development at True Street, Berry Pomeroy</p> <p>The planning group will consider a detailed response but the in principle decision was to lodge an objection on the grounds of development outside an existing development envelope, inconsistent with current policies and would lead to the further spread of Totnes to Berry Pomeroy.</p> <p>c. Brimhay</p> <p>The Committee noted the correspondence received and had nothing further to add to the response already provided to the member.</p> <p>d.
